Updates

Police update – Ammo Sanghera (PCSO, LP)

No representative of Leicestershire Police present at the meeting.

City Wardens written update – Darren Evans (City Warden, LCC)

Work is ongoing on Queens Road, and we are working with a number of business offering advice on their responsibilities on waste on the highway.

We are also looking at a **Bins On Streets** project around the area and I'll be conducting a **Duty Of Care** project on the businesses making sure that all their waste is being removed correctly.

UoL update - Michael Flannagan (Director of Estates & Digital Services, UoL)

Started new term, fully open, recruited well, in full operations, all students and staff on site, all buildings busy all activities (learning, research, sports) very busy. Pleased to see students back and campus looking really alive. Recently refurbished buildings all in use.

Freemen's Common: first Nixon Court residential block in full occupation (200 students) & second Nixon Court block due for completion 05 Nov 2021 (another ~200 students). 5 residential blocks of ~800 to complete Sep 2022.

Freemen's Cottages: complete, handed over & occupied

Teaching & Learning Centre: due for completion Nov 2021, opens Jan 2022

Q (BM): Car parking open?

A (MF): Car park is open, staff are using it and members of the public are able to use it at the weekends.

Q (VM): How many students attending UoL are accommodated by UoL as there are lots of planning applications for Purpose Built Student Accommodation, and will there be a surplus of student accommodation as there was of office accommodation in the 1970s?

A (MF): 4,500 of 18,000 – UoL promises 1st year students a room in either their 'City' site (Freemen's / Nixon) or Oadby. Students usually look to move into private accommodation in subsequent years. Private student accommodation developed in the city is designed as an offer to UoL & DMU students & medium term demographic view is that numbers of students will increase, but there may be too many developments going on at the moment.

Q (BM): Will be a lot of students crossing Welford Road once T&L centre opens

A (MF): UoL comfortable that arrangements & improvements should provide safe passage to students crossing WR, but answer lies in timetabling to avoid frequent crossings of WR and keeping arrangements under review

Q (Nick): Any more living walls on new blocks?

A(MF): Only one on FC site is on T&L centre (there is another on George Davis Centre on other side of campus)

UoLSU update – Gareth Oughton (Chief Executive, UoLSU)

Students are enjoying being back on campus, good compliance with mask wearing & safety in lectures.

Continuing work on WQE gate, been working extensively with local MP and Council & UoL, have written to WQE re concerns over student & resident safety.

Had lots of feedback on local parking scheme from students who have had their applications denied, proposing to LCC that student registration satisfies term time proof of address

Keen to develop ways of encouraging students to shop local, so welcome business owners getting in touch for help to achieve this – email susales@leicester.ac.uk – looking to do activities over course of coming term.

Working with LCC on a bid for extending lighting (& CCTV?) in Victoria Park – not part of PCC funding recently announced.

Action: IB to send info on PCC funding to GO.

Leicester Transport Plan & Workplace Parking Levy

Consultation on Leicester Transport Plan 2021-2026 closed recently.

There will be e-Bike docking stations coming to Clarendon Park soon.

Nottingham has the only WPL in the northern hemisphere!

CP Planters consultation – site by site analysis plus recommendations in due course.

Questions

Q (BM): Increased usage of mass transport depends on frequency and price – any comments?

A (AC): Enhanced Partnership with bus operators will help deliver integrated & regular (every 15 min) bus services & improved pricing using Tap-on/Tap-off, especially if across bus operators. Working closely with bus operators, sticks and carrots. Best position since 1980s deregulation.

Q (JH): Would love to walk more but can be very dark when walking along street between bus stops & can feel unsafe.

A (MF): Over 33,000 streetlights replaced with LED lighting, remote controlled & can dim later in evening – programmed to be brighter early evening and lower setting later on, to reduce both carbon emissions & energy costs. Task group looking at identifying key walking & cycling routes where lighting levels need to be higher, but balancing act between public safety and balancing the books.

A (AC): Do let us know if there are any specific areas where there is a concern need better lighting

Q (IB): On behalf of Queens Road traders, now that we know we don't really catch Covid-19 outdoors, is there still any need to have sections of Queens Road coned off for pavement extensions?

A (MF): Last of parking spaces released as of yesterday, still leaving 'gateway features' to help reduce traffic speeds along Queens Road. Also had concerns raised about issues around Grounded Kitchen in terms of parking and delivery courier collections.

Q (BL): Residents Parking Scheme – any provision for resident non-drivers to get passes for tradespeople?

A (MF): Now a voucher system can be purchased to allow tradespeople to park throughout restricted hour – contact LCC Parking Services via parkingoffice@leicester.gov.uk

A (DM): Key thing is want to stop commuter parking and stop people parking for months at a time and not really using their car, so we can free up spaces for people who live here and want to come here to shop.

Q (KW): Lots of our students are being rejected – is there anything you can do to help with this? Many students have car registered at parents address to reduce costs.

A (DM/MF): Car must be registered at the address (same as across whole city) – students can bring car but would need to register it at address to be eligible for permit.

Q (JW): House next door is building site, and workmen often park across entrances.





A (MF): Tradesmen need permit to park in zone during restricted hour, same as anyone else, but shouldn't be blocking driveways.

Q (NA): Is Clarendon Park going to have an e-Bike dock?

A (AC): Yes, and can request additional docking stations via <u>Widen My Path</u> or lobby ward councillors, next closest will be adjacent to Victoria Park, but hope up Queens Road and beyond soon.

Q (JC): Keep cycle lanes clear of glass & debris using smaller machines?

A (MF): Working with cleansing department to address this.

Q (BL): Cyclists still using New Walk despite cycle ways on London Road?

A (AC): Working with FNW to develop new interventions to address the problem.

Q (BM): E-scooters?

A (MF): Currently unlawful unless part of one of the 31 pilot hire schemes – none in Leicester. Police enforcement issue.

A (AC): Real concerns over their use even where part of the pilot schemes.

Q (JG): Has varying school times been considered as a way to spread rush hours out?

A (DM): Not in power of council now that many schools have become academies.

A (MF): Teachers may not appreciate it! There was some staggering during pandemic.

Q (KL): What is meant by 'gateway' features?

A (MF): Trees in boxes, ivy screens, wands at junctions, but need to have a conversation / consultation about improving Queens Road. Already have funding for scheme on Braunstone Gate.

Planning

Permit Parking Zone

Overview of timelines for phase 1 & 2 areas

Phase 1: 20% spaces free before implementation, 37% after implementation. Penalty notices have continued down their downward trend.

More business than resident permits in Phase 1, many more resident permits than business in Phase 2.

Phase 2: 25% spaces free before implementation, post implementation data to follow.

Phase 2 issues: displacement parking onto Greenhill & Raeburn Roads, treatment of larger employers, e.g. Avenue Primary School.

Q (BM): What was the source of the feedback LCC received?

A (MF): Letter early August inviting further feedback from residents, little response, so general acceptance.

A (DM): Have also had comments about displacement parking to other side of Welford Road.

Electric Vehicle charging bays

16 locations around CP across 10 different roads. Two thirds done, so reasonable progress being made.

Q (BM): Have they been installed elsewhere & what evidence is there of take-up rate?

A (AC): Pilot scheme in two areas, Clarendon Park & Westcotes, but too early to tell on take-up.

A (AC): 50% of housing in Leicester doesn't have off-road parking, so it's a big challenge.

Q (SW): Why so many around junction of Howard Road & Hartopp Road – they're taking up spaces near Victoria News & Booze & resulting in anti-social parking on crossing points.

A (PK): Positioned near where people who responded to consultation said they had EVs. Still a learning exercise, but needs to happen quickly.

Q (JH): Does the count on spaces include analysis of streets just outside the area?

A (IB): No displacement survey data for phase 2 yet, but expect by next meeting.

A (DM): Similar comments from the 'writer's streets on the other side of Queens Road.

Public Rights of Way: WQE & UoL

WQE Right of Way: since last meeting LCC ePetition launched & the 22 signatories contacted by LCC, further petition on Change.org (180 signatures)

Action: contact Change.org signatories and ask to complete LCC form (PK)

Q (BM): What are the timelines for addressing this unilateral action by WQE?

A (PK): Technical process, decision likely March 2022, but in meantime, route is locked off. If decision is to establish the right of way, WQE have a right of appeal, so could extend the process.

UoL Right of Way: UoL have contacted LCC about buying Mayors Walk – the road that forms the main entrance into UoL and runs through to Victoria Park. UoL have said there is no intention to close this off, but given experience with WQE, may be worth establishing this as a Public Right of Way as well.
